II. Approval of the agenda for April 10, 2018

There was a motion to move DEQ's report to after New Business to respect that Joe Francis and Jim Macy had to leave the meeting early. Motion made by Sharon Medcalf; Jim Heine seconded the motion. The motion passed by unanimous acclamation vote with no abstention or dissenting votes.

III. Approval of the minutes from the January 16, 2018 meeting

There was a motion by Bryan Tuma to accept January 16, 2018's meeting minutes as presented; Sharon Medcalf seconded. The motion passed by unanimous acclamation vote with no abstention or dissenting votes.

IV. New Business


a. LEPC Resource Toolkit Ideas

Discussed in strategic planning, developing a toolkit for LEPCs. James Rashilla combined existing material with new material to create LEPC Handbook as a reminder to duties of LEPC, basic understanding of rules and responsibilities of LEPC. This handbook is subject to changes based on feedback from SERC. Hazardous materials emergency preparedness grant listed; there are also workplace training grants available. Steve Danon and James Rashilla discussed grant options for LEPCs. All private employers in the state pay into unemployment insurance fund. The interest on this fund is very large and can be used by an employer applying for a grant from these funds and can be for topics related for training, enhancement of commercialization of business, and increased knowledge of employees. The employer or employers submitting for the grant have to have a match in the manner of time or facility availability. Outside instructors can be hired for instruction as part of the grant. Joe Oswalt has used this grant in the past for a variety of trainings. The grant has to be planned a quarter ahead. There is no cap on the requested amount other than the soft match contribution. State organizations are not entitled to use these funds but can do this in conjunction with a private partner. May have to use these funds in the same quarter they are granted (Steve was unsure on this issue). The handbook contains the guide that was developed a few years ago and will assist as an overview/guidance for areas with developing or creating an LEPC. This topic will be revisited in July – provide feedback to James for inclusion. James will send the existing version of the guide to the SERC.

b. Review LEPC Survey from 2016

The PPC conducted a survey of LEPCs to assess Nebraska LEPCs in a variety of factors (who completed the survey, survey participant role on LEPC, reasons for counties not having an LEPC, traits of successful LEPCs, LEPC training usefulness, knowledge of LEPC Guide, HazMat Plan Format preferences, and areas for LEPC improvement). The community outreach subcommittee can utilize the survey information to drive their efforts. Steve Danon mentioned that SERC should set up a Facebook page as Nebraska response LEPC as a closed group and allow for sharing of events, questions, concerns and would address the concern about LEPCs not having enough interaction with the SERC. The only communication method currently in use is through email. The state has regulations regarding hosting and using Facebook on the state network. State pages may not be able to have a closed page because of open/public laws. The LEPCs may be able to have and administer their own Facebook pages. A private enterprise may be able to host and administer a Facebook page on behalf of the SERC. Bryan Tuma and Jim Macy will check with OCIO on the procedures involved in setting up a page and will report in July. The outreach committee should meet prior to the next meeting to discuss these options. (John, Bryan, Steve, and Tim are the outreach committee). A new survey is not necessary until the existing results are addressed.

c. Improving LEPC coverage



James provided a map of existing LEPCs (pictured above). The white counties do not have an LEPC. James will continue to work with these counties to create an LEPC. Saunders, Hamilton, and Otoe Counties have LEPCs that only exist on paper and do not appear to be active. James is working with the North Central EM's to create an LEPC and Johnson/Pawnee counties. Dawson and Buffalo counties are big concerns because of the environmental impact they have on the state. There is not a lot of support for LEPCs in this area. The Southeast corridor is also an important area missing an LEPC and Joe Oswalt is willing to assist with connections to James. Platte and Dakota counties have major manufacturing and Tim Hofbauer is working on building a relationship with the new Fire Marshal to future LEPC. Sue suggested coming up with a one page informative flyer on why an area should have an LEPC. James will work on this and distribute to the SERC for additional distribution.

d. Nebraska Hazmat Conference Planning Committee

Call for volunteers (John Grimes, Steve Danon, James Rashilla, Sue Dempsey, and Kim Plouzek). North Platte has expressed interest in hosting a state LEPC Hazmat conference around October to increase participation. 2-3 days with speakers. James has a list of potential vendors. The 2019 EPA Region 7 conference will be in Omaha. Sue Dempsey is on the regional LEPC planning committee.

e. Other

FBI is putting on a pipeline table top on June 7th in Lincoln location and time TBD. It will be an all-day event, need Sue and Joe Francis (or another member of DEQ) will attend to represent the SERC

V. Old Business

a. LEPC Membership Applications Approval (Vote)

There were 126 applications summarized onto one chart for SERC review. Dana Miller made a motion to approve the LEPC applications; Bryan Tuma seconded this motion. The motion passed by unanimous acclamation vote with no abstentions or dissenting votes.

b. SERC Membership

i. Matthew DiVito (New Approved Representative for the Trucking Industry):- Welcome!

Matt served in the U.S. Army for eight years and then was hired by Crete Carrier in Atlanta. Matt moved to Lincoln in the last year to work in the safety department at Crete Carrier corporate. He runs the hazmat shipping for the company. With Matt's appointment, all of the SERC positions are filled.

c. Approval of bylaws

The revised bylaws for the SERC were reviewed before meeting. There were several corrections and updates which were sent to the Board members for review. The position title under Article IV continues to be listed as SARA III Title Coordinator who will serve as the information officer coordinator. Sue Dempsey made a motion to approve the bylaws with the corrections and changes; Polly Jordening seconded this motion. The motion passed by unanimous acclamation vote with no abstentions or dissenting votes.

VII. SERC Member Reports DEO (Joe Francis & Jim Macy)

Joe took a moment to thank Terri Blunk (EPA) for her help with Tier II season, which recently concluded. Eppley Airfield had a spill of 10,500 gallons of jet fuel but it was contained, and none of the spill made it into the storm sewer. Kirk Morrow represents regional response team and attended a meeting recently; Iowa is looking at how they conduct business and when they respond to incidents. Iowa governor ended their SERC and went to placing responsibilities on local emergency managers. Kansas has had changes in their administration. Missouri is fully staffed and is getting new equipment. Nebraska is in burn season and working with DHHS, Douglas County, and city of Omaha to monitor air quality.

NEMA (Bryan Tuma)

Since last fall, NEMA has assisted with the aftermath of hurricanes that severely impacted Texas, Florida, and the Virgin Islands. Nebraska has contributed disaster relief to the tune of \$1.2million to Texas, \$350,000 to Florida, \$320,000 to the Virgin Islands. The money comes out of governor's emergency fund then reimbursed by the state. EMAC is becoming the backbone for national response. State to state readiness, resources, and training. Emphasizes relationship with public and private sector and is quickly emerging as a key component of response. The capacity to engage private partners is becoming very important. There is a conference in September in Omaha to enhance these partnerships.

The Nebraska Energy Office has requested a grant through US Dept. of Energy for an Energy Assurance Grant. This grant focuses on all sectors of energy and helps build a more robust plan regarding what happens if the pipelines, electrical grids, or other energy sources are compromised This will be an annex to state emergency operations plan.

Eight states are located on the New Madrid Fault Line, and Nebraska is designated as a reception state and will assist evacuations with transportation, goods and services, energy in event of an incident related to the Fault Line. Our response and capacity to support this fault will be tested by hosting a full-scale comprehensive exercise in 2020 that will involve many state agencies. FEMA is also developing a several day exercise called "Shake and Fury" to be held on June 4, 2019 to examine how state and federal agencies coordinate together. Vigilant Guard 2019 is MO National Guard (NE is in 2020) will host a New Madrid Fault exercise.

Missouri was contacted by US State Dept. and asked to do a repeat creation plan in the event of a missile event in South Korea. NE, as a reception state for the fault will watch this exercise because it's related and will have similar activities. Missouri has said they can receive either at St. Louis or Kansas City. If this plan passes, they will likely reach out to Nebraska for assistance as a reception state.

On April 9th, NEMA received notification that Fort Calhoun Nuclear Plant is completely shut down and decommissioned.

REPP program calibration lab is looking for a new manager for the calibration lab. WIPP shipments are decommissioning, materials received from Argon National laboratories will begin shipping through I-80. DOE will conduct a WIPP roadshow at four locations with a shipping container and informational sessions. This event is designed to educate public safety, emergency responders on materials and processes of the shipments. NEMA needs to review the transportation plan in the emergency operations plan since the WIPP is restarting.

EPA- Region 7 (Terri Blunk):

Farmers Do Not Need to Report Air Releases of Hazardous Substances from Animal Wastes - The Consolidated Appropriations Act 2018 Title XI, called the "Fair Agricultural Reporting Method Act" or "FARM Act" exempts the reporting of air

emissions from animal waste at a farm under CERCLA. When the D.C. Circuit Court of Appeals issues its mandate vacating the 2008 final rule farms will remain exempt from the CERCLA reporting requirements. For more information visit www.epa.gov/animalwaste

VIII. Public Forum / Presentation

a. HMEP (Hazardous Material Emergency Planning) Grant Utilization for LEPCs (Tom Smith, Region 44 Emergency Management)

Tom Smit, Region 44 Emergency manager gave a breakdown of the basics of HMEP Grants and how his local LEPC's use HMEP Grant dollars. The Hazardous Materials Transportation Act (HMTA) authorizes the US Department of Transportation (USDOT) to make grants available to States, Territories, and Indian Tribes to develop or improve emergency response plans and to conduct training of public sector employees who respond to emergencies. The USDOT established the Hazardous Materials Emergency Preparedness (HMEP) Grant Program using registration fees paid by shippers and carriers of hazardous materials.

The HMEP Grant supports the reduction of hazardous materials releases & exposures; the improvement of local public sector response & planning and enhancement of Title III of the Superfund Amendments and Reauthorization Act of 1986.

The HMEP grant is divided into two categories; planning and training. LEPC's may apply for funding to assist with the planning component, training is offered through the Nebraska State Fire Marshal and the Nebraska Emergency Management Agency.

Eligible Activities for Planning

The following items are considered eligible for funding under this program:

- Development, improvement and implementation of emergency plans
- Commodity Flow Study
- Assessment of local emergency response team capabilities

• Drills and exercises associated with emergency preparedness plans and hazmat transportation

Funding Restrictions

The following items are considered ineligible for funding under this program:

- Exercise: personnel expenses, overtime, travel, group meals, or per diem for participation in drills and exercises. However, equipment rental and other consumable supply expenses for drills and exercises may be allowed depending on the reasonableness of the costs.
- Expenditures funded under another federal or state grant
- Equipment/System purchases (operational & response)
- Salaries
- Group Meals
- General Office Supplies
- Expenses not related to hazardous materials
- Expenses counted as match funds toward another program
- Any costs without supporting documentation

IX. Adjournment

- a. Next Meeting July 10, 2018 SCC. October possibly outside of Lincoln. Possibly National Park Service in Omaha or western/central NE.
- b. The motion for adjournment was presented by Bryan Tuma; Polly Jordening seconded the motion. The motion passed unanimously via acclamation vote, with no dissensions or abstentions. Meeting was adjourned by John Grimes at 3:08pm.

**Region 7 Assists with National Disaster Response Efforts

In 2017 and 2018, EPA Region 7 has deployed multiple personnel to support hurricane and wildfire responses in Texas, Puerto Rico, US Virgin Islands, and California. EPA Region 7 conducted 62 deployments to assist Region 6 in response to Hurricane Harvey that impacted Texas. Due to Hurricanes Irma and Maria, Region 7 had approximately 45 deployments to support Region 2 in response efforts in Puerto Rico and the Virgin Islands. Finally, Region 7 had 40 deployments to support Region 9 in response to wildfires in Northern and Southern California.

**Highlights from Removal Actions Being Conducted in Nebraska

Northwestern Metals Site in Lincoln. The original smelter ceased operations in the 1960s. EPA and NDEQ have sampled residential yards near the former smelter to check for lead in the soil. EPA plans to begin residential yard lead remediation in April 2018.
